**AFFIDAVIT ON BEHALF OF THE PETITIONER**

1. Adani Power Maharashtra Limited (now in the new name of Adani Transmission (India) Limited) has filed the present Petition before this Hon'ble Commission for amendment of Transmission Licence No. 2 of 2009 on July 15, 2014 for inclusion of two Bus Reactors and associated bays at Tiroda Substation as a part of Assets forming part of the Transmission Licence.
2. On 2.12.2013, Adani Transmission (Gujarat) Limited was incorporated to, inter alia, carry on the business of establishing, commissioning, setting up, operating and maintaining electric power transmission systems under the Indian Companies Act, 1956. Adani Transmission (Gujarat) Limited's name was changed to Adani Transmission (India) Limited ("ATIL") with effect from 13.02.2014 which is a wholly owned subsidiary of APL.
3. In order to achieve utmost synergy and efficiency of operations and management, to pursue focused growth opportunities in the power transmission business and to



ensure better regulatory compliances, the Petitioner, as part of business reorganisation, decided to restructure its power transmission business. To effect such reorganisation, the Petitioner and ATIL filed proceedings before the High Court of Gujarat for approval of a scheme of arrangement (the "Scheme"). The Hon'ble High Court vide its Order dated 26.09.2014 granting the approval for the Scheme.



Subsequently, on 17.10.2014, Adani Power Maharashtra Limited and Adani Transmission (India) Limited, collectively filed the Petition (Case No. 189 of 2014) before this Hon'ble Commission for Assignment of the Transmission Licence of Adani Power Maharashtra Limited in favour of Adani Transmission (India) Limited.

5. The Hon'ble Commission held Technical Validation Session (TVS) in the present Petition on 25.11.2014 wherein the Hon'ble Commission clarified that the Petition in Case No. 189 of 2014 would be disposed-off first and based on the outcome of the Licence Assignment Petition, the Licence Amendment Petition in Case No. 136 of 2014 will be processed for subsequent Notice Publication and Public Hearing.
6. Subsequently, the Hon'ble Commission has issued the Order in Case No. 189 of 2014 on 08.12. 2014 allowing the Assignment of Transmission Licence of APML in the name of ATIL.
7. As per the Scheme, upon coming into effect of the said Scheme, all legal or other proceedings by or against APML, whether pending on the appointed date or which may rise in future in relating to the Transmission business of APML shall be continued and enforced by or against ATIL.
8. In view of the above, henceforth, all the matter pertaining to the present case shall be taken up by Adani Transmission (India) Limited. Accordingly, the present Petition including all the submissions under Case No. 136 of 2014 for Amendment of Transmission Licence may kindly be considered as amended to that effect.
9. It is further submitted that the Petitioner has also carried out requisite changes in the Public Notice submitted along with main Petition. Copy of the same is



attached herewith and marked as **Annexure A** for approval of the Hon'ble Commission so as to release it in Newspapers as per Section 7 of the MERC (Transmission Licence Conditions) Regulations, 2004.

10. In view of above, I say that the Prayers of the Petition No. 136 of 2014 be considered as follows:

a. Approve the Public Notice for amendment of "Transmission Licence for Adani Transmission (India) Limited"

b. Amend the Transmission Licence for Adani Transmission (India) Limited (Licence No. 2 of 2009) granted u/s 14 of the Electricity Act, 2003 and Maharashtra Electricity Regulatory Commission (Transmission Licence Conditions) Regulations, 2004, as follows:

i. 400 KV Double Circuit Transmission Line with quad conductor from Tiroda (Gondia) to 400 KV Warora Switching Station

ii. 2 Nos., 400 KV bays for Tiroda-Warora Double Circuit Transmission lines at Tiroda Project Switchyard

iii. 2 Nos. 400 KV bays for Tiroda-Warora Double Circuit Transmission lines at Warora switching station

iv. 2 x 80 MVAR Bus Reactors along with associated bays at Tiroda Substation

c. Condone any inadvertent omissions/ errors/ shortcomings and permit Adani Transmission (India) Limited to add/ modify/ change/ alter this filing and make further submissions as may be required at a future date.

d. Pass such further Orders, as the Hon'ble Commission may deem fit and proper keeping in view the facts and observations of the case.

3. **Rationale for the proposed alteration or amendment:**

The 400 kV D/C Tiroda-Warora Transmission system planned by STU was included in the STU Transmission plan for FY 2010-11 to FY 2014-15. Adani Transmission (India) Limited (formerly in the name of Adani Power Maharashtra Limited) was granted the Transmission Licence No. 2 of 2009 on July 06, 2009 (amended on March 30, 2011) for executing the said system. Due to High voltage

prevailing in Wardha and Warora areas coupled with the line capacitance at the time of commissioning of Tiroda-Warora line, it became imperative to compensate the impact by way of installation of Bus Reactor during charging as well as Operation. The same has been highlighted in various Technical Reports, correspondences from WRLDC/SLDC and has also been stipulated in the Commission's Order in Case No. 51 of 2013 and Case No. 190 of 2013. Accordingly, Bus Reactors need to be considered as an integral part of APML's Licensed Transmission System.
