Instructions to bidders participating in closed sealed tender cum e-Auction.

1. The intending participants are requested to visit our web site www.adanipower.com and read the instructions & procedure explained under the "Tenders" section. For any further clarification/queries, please contact us on Telephone: (079) 25557400 Telefax: (079) 25557177.
2. ONLY Registered Participants are allowed to participate and bid in our closed sealed tender cum Live-Auction Online. To become Registered Participant, you are required to fill-up the Form (Annexure –A) available on our said website. Please read instructions carefully.
3. All those bidders who have dully filled the Registration Form and wish to participate in the auction, should send their Caution Money Deposit (CMD) by DD of nationalized bank / RTGS favoring '**Adani Power Rajasthan Limited**' payable at Ahmedabad along with their highest bid for all/selected items as per annexure 'C' along with the Registration Form attached herewith through courier or personally and obtain necessary receipt for the same. CMD amount along with sealed closed bid as mentioned against each lot of scrap in Annexure 'C' must reach the **Seller (Adani Power Rajasthan Limited)** on or before 05:00 p.m. of **16.05.2015**.

For example if any bidder wish to participate in all types of scrap declared in Annexure 'C' than he should deposit CMD amount of all the items as mentioned in Annexure 'C'. However if any bidder wish to participate in any specific item lot/lots than he should deposit equivalent CMD amount mentioned against each lot in Annexure 'C'. CMD should be paid by DD nationalized bank only favoring Adani Power Rajasthan Limited, payable at Ahmedabad.

Forms received after due date may not be allowed to participate at the Live-Auction and their DD will be returned to them through Courier at his/their risks. Hence, in your own interest, you are requested to complete all the formalities to become Registered Participant in advance and well in time.

3.1 Sealed tender cum e-Auction process.

- 3.1a. Bidders shall submit their highest bid for all/selected items as per Annexure 'C' in a sealed Envelope clearly mentioning on their letter pad Lot No , material description, quantity and the Priced sealed bid along with CMD amount as mentioned against each item in annexure 'C'. Sealed bid along with CMD shall be submitted in a sealed envelope marked "Sealed tender for Scrap Lot # 13) by hand or courier at following addresses and ensure the sealed bid should reach the given address latest by 16-05-2015 failing which the bid shall not be considered.

4. Successful participant's CMD will be adjusted against Earnest Money Deposit (EMD) of that particular lot
5. **Please note the DD against CMD must be sent to the Seller in advance along with Registration Form attached herewith on or before 05-00 PM, on 16-05-2015. The Seller is not liable for the delay or late receipt of DD whether sent through Courier or Post.**
6. On receipt of sealed tender bids , APRL management may decide to conduct e-auction for all/selected items on adani portal.com. In such case, All the Bidders who have submitted the requested CMD and

completed Registration Process shall be provided User ID and Password to participate in the e-Auction by Seller.

7. Please do not reveal / pass your User ID and Password to any other person/s. It is your personal property and we will not be responsible for any leakage or misuse or illegal use of your User ID and Password. Nevertheless, you will be held personally liable to the Seller for any misuse or illegal use of your User ID and password by other person/s and any successful transaction online by such unauthorized person due to your negligence will be considered as your own transaction and you will be required to fulfill the Contract as per terms and conditions of the sale.
8. Once you login, you cannot use the same username and password to login from another machine before logging out from the previous one.
9. For your perusal, an Online Auction DEMO/Mock Auction shall be available only for Registered Participants/ Members to practice and get acquainted with the system one day prior to the Live Auction. **Nevertheless, if you wish to learn thoroughly in person, we can train your representative by prior appointment, PROVIDED you have paid CMD in advance.**
10. CMD of unsuccessful participants will be sent back by the Seller through courier at the address given by them within 10 working days following the date of e-Auction or declaration of result on receipt of "Request for Refund of CMD -Cum- Letter of Confirmation" (Annexure - B) through Fax or Courier from the respective bidders
11. Taxes & Duties mentioned in the catalogue are only indication and Actual rate in force at the time of delivery will be charged.
12. In all the above sales, the sale will get automatically extend for 5 minutes ONLY IF THERE IS A BID IN LAST 5 MINUTES OF SCHEDULE END TIME. For Example, Lot No. 1 Starts at 11:00 a.m. & Ends at 11:20 a.m. then, **ONLY IF THERE IS A BID/S BETWEEN THE TIME 11:15:01 AND 11:19:59, THE LOT WILL EXTEND FOR 5 MINUTES, OTHERWISE IT WILL BE CLOSED DOWN.** Please note, even if there are five bids within extended period of five minutes, the extension will ONLY be for 5 minutes and not more. The extensions will automatically be continued till somebody bids within five minutes. If at any extended time, no body increases the offer within five minutes, the computer will shut-down the bidding of that Lot and sale for that lot will be treated as ended there. **The clock at the Live-Auction may not show exact time of bid ending but it will count 5 minutes and shut down. So please do not wait till last moment, but increase your Bid at least one minute in advance.**
13. CMD/EMD will carry no interest.
